	<ul> <li>RM provided an update on the latest figures on registrations and moves.</li> <li>Residents raised concerns that Countryside had not been present at the last two Estate Board meetings and requested their attendance at future meetings.</li> </ul>

	<ul> <li>Residents agreed on extended hours for the Festive Event. 9:00 – 14:00 on 16<sup>th</sup> December.</li> <li>RM confirmed that reindeer will be on Estate from 9:30 to 12:00.</li> <li>Residents suggested erecting a promotional banner on either side of the two gates. RM to look into</li> </ul>





	•	A resident highlighted that Camden Giving has launched the Camden Pound which aims to ensure
		that money stays within Camden owned businesses. Residents suggested sourcing caterers and
		vendors from Camden Pound if possible.
	•	RM strongly encouraged residents to send ideas, contacts within the community and vendor details
		to him as soon as possible given event timescales.
	•	Residents made several suggestions for the event/festive period including:
		o Festive lighting
		o Big chess/big outdoor games. One resident suggested engaging with Boss Leisure, a local
		business that rents these out.
		<ul> <li>engaging workers for play centres, either for this event or future half term events</li> </ul>
		<ul> <li>making festive goodie bags for children, rather than individual presents</li> </ul>
		o craft ideas including facepainting, card making, arts and crafts table, decorate your own
		gingerbread men.
	•	RM relayed a query from PRP (the architects on the Juniper Crescent regeneration), asking if residents would prefer them to attend the Festive Event. Residents requested that PRP attend January consultation events instead.  RM/SB to look into more caterers, Countryside have a contact from previous events that could be
		a possibility.
	•	A resident volunteered to rework the flyer and send to other Estate Board members/RM for review.
	•	RM to arrange print and distribution of Festive Event flyer.
	•	RM to assist residents in filling out the application form for event budget.
	•	A resident highlighted that a first aider needs to be present on the day.
